Functions & Handling

1. Activation

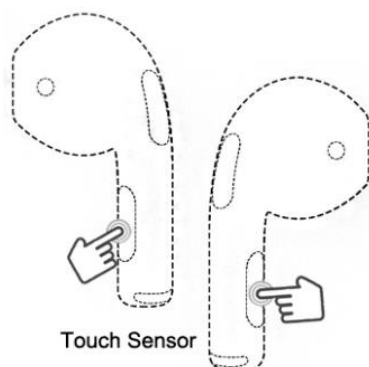
By opening the charging case, the ear phones are automatically turned on, accompanied by the prompting sound. The left and right earphones automatically complete their pairing.

2. Bluetooth Connection

Turn on the bluetooth function on your Apple mobile phone and search for "LEICKE EP21507". Doing so for the first time, you need to manually connect the device. Afterwards, the pairing is successful.

3. Using the touch buttons



Function	Operation
Play/Pause	Press once
Next Song	Press 2 times
Previous Song	Press 3 times
Answer/Hang up	Press once

4. Voice Assistant

Long press the headset touch button. Voice wake-up is supported by saying "Hey, Siri!".

5. Low battery warning

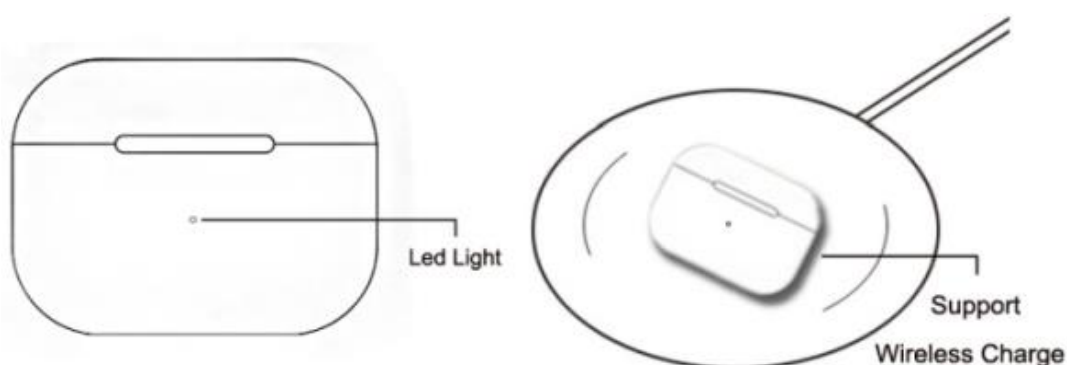
When the battery is low the headset emits "DiDiDi" alarm sounds. Afterwards, the headset enters the standby mode.

6. Charging the headset

Insert the headset into the charging case, then close the lid and the headset is automatically charged.

7. Charging the base

Please charge the headset using the iOS cable. Wireless charging is supported. When the battery is fully charged, the green LED indicator lights on.



Safety Notes

1. Do not expose the product to high temperatures, corrosive or high-pressure environment.
2. Do not attempt to disassemble the earphones, or to replace any electronic components in it.
3. If the device has fluid leakage, please stop using it.
