



Elements Testing Flow Chart

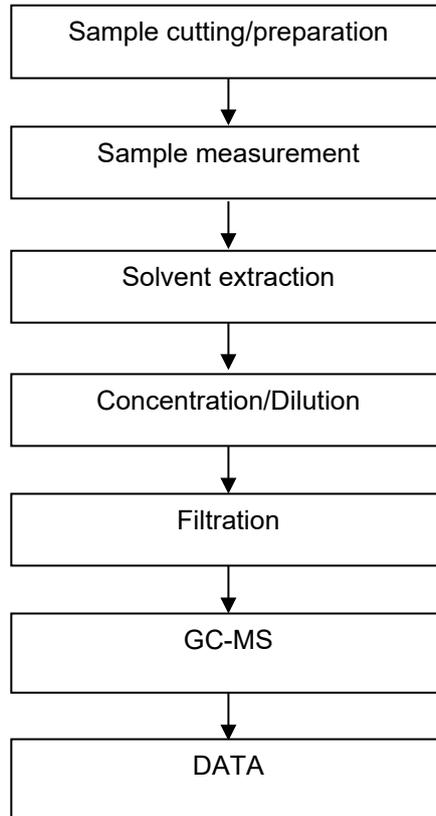
